To the City of Wanneroo ("the City")

Report on the Statement of Income and Expenditure

We have audited the accompanying Statement of Income and Expenditure for the City of Wanneroo in relation to Cell 2 for the year ending 30 June 2024.

Responsibility for the Statement of Income and Expenditure

The City is responsible for the preparation of the Statement of Income and Expenditure for Cell 2. This responsibility includes establishing and maintaining internal control relevant to the preparation and presentation of the Income and Expenditure Statement of Cell 2 in accordance with the District Planning Scheme No. 2 ("DPS 2").

Auditor's responsibility

Our responsibility is to express an opinion on the Statement of Income and Expenditure for Cell 2 based on our audit. We conducted our audit in accordance with Australian Auditing Standards and the requirements of DPS 2. These Auditing Standards require that we comply with relevant ethical requirements relating to the audit engagement and plan and perform the audit in order to express an opinion on the preparation and presentation of the Statement of Income and Expenditure to the City.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the Statement of Income and Expenditure. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the Statement of Income and Expenditure, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the City's preparation and fair presentation of the Statement of Income and Expenditure in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the City's internal control.

These procedures have been undertaken to form an opinion whether, in all material respects, the Statement of Income and Expenditure is presented fairly in accordance with the DPS 2. We disclaim any assumption of responsibility for any reliance on this report to any person other than the City, or for any purpose other than that for which it was prepared.

EAST WANNEROO - CELL 2

Cell 2 Includes the suburb of Sinagra and is generally bounded by Pinjar Road, Wanneroo Road and Dundebar Road. Over \$13 million worth of infrastructure works have been completed in this Cell. The Cell is only partially developed (52% of developable land) and remaining costs primarily relate to the finalisation of the Dundebar Road upgrade and several large POS acquisitions. The Ingham Poultry Farm has now been relocated and development of the area is now progressing quickly.
