

## The Wanneroo Botanic Gardens' Magic of Christmas 2024 City of Wanneroo Residents Competition

## **Terms and Conditions**

- 1. This Competition is a promotion run by the City of Wanneroo ("Promoter") ABN 64 295 981 165.
- 2. Entries and information on prizes and how to enter form part of these Terms and Conditions.
- 3. Participation in this Competition constitutes acceptance of these Terms and Conditions.
- 4. Entry to this Competition is free and open only to persons aged 18 years and over who live within the City of Wanneroo.
- 5. Employees of the Promoter and their immediate family members are ineligible to enter.
- The competition commences 8am AWST (Australian Western Standard Time) on Friday 13 December 2024 and closes 5pm AWST on Monday 16 December 2024 ("Competition Period").
- 7. Entries received after that time or not completed in accordance with these Terms and Conditions will not be eligible to win a prize.
- 8. To enter, participants must post a 'comment' with the name of their favourite Christmas tradition on the competition post published on the Promoter's official Facebook page. The comment must be posted on the competition post itself (i.e. not shares of the post) to be considered for the prize draw.
- 9. The Promoter reserves the right to delete any inappropriate entries (e.g. any entries using obscene language or that are not relevant to the competition). These deleted entries will be ineligible to win a prize.
- 10. Incomplete or indecipherable entries will be deemed invalid.
- 11. Only one entry per participant.
- 12. 10 individual winners will be selected from the eligible entries received ("Winners").
- 13. The Winners will be chosen at random by software, from all entries received and verified by the Promoter on Tuesday 17 December 2024.
- 14. Entries are eligible to win one prize only.
- 15. The Winners drawn will receive entry to Wanneroo Botanic Gardens and a Mini Group Pass valid for 36 holes of glow golf for 2 adults and 2 children or 1 adult and 3 children, valued at \$88.00 valid for 12 months.
- 16. The Winners will be notified via the Promoter's official Facebook page by 5pm AWST on Tuesday 17 December 2024. The Winners will have 24 hours from the time the Winner is notified by the Promoter, to contact the Promoter to claim their prize. If the Winner does not respond to the Promoter within this time, the Winner will forfeit the prize and a new winner will then be redrawn from the total entry pool.



- 17. Winners will need to provide the Promoter with personal contact information and proof of City of Wanneroo residency to claim the prize. Winners agree for the Promoter to share this information with the operators of the Wanneroo Botanic Gardens who will contact the Winners directly to collect their prize.
